THE STUDENTS, SOME WHO RECEIVED TWO SCHOLARSHIPS, WERE SELECTED THROUGH A COMPETITIVE PROCESS EVALUATING FINANCIAL NEED, ACADEMIC ACHIEVEMENT, AND SPECIAL PERSONAL CIRCUMSTANCES LIKE SINGLE PARENTS OR FIRST GENERATION STUDENTS.
