<u>Linkage with Community</u> Elizabeth Stephens, Teacher Scientist Partnership Program at PNNL	Elizabeth Stephens shared with the Board information regarding PNNL's unique professional development opportunity, the Teacher Scientist Partnership (TSP), for middle and high school STEM teachers. TSP provides an opportunity for PNNL researchers, scientists and engineers to work with STEM educators tackling real world, scenario-based, scientific challenges that are aligned with PNNL's research and connected to Washington State science and learning standards. During 2022, TSP served 31 local teachers from 19 school districts who in turn impacted 3,593 students. The TSP program will be partnering with CBC's Cyber Security Program in the fall of 2023. Findings and results from TSP learning opportunities are shared with stakeholders, both internally and externally, and are available on PNNL's website and used to develop the next generation work source.	
Celebrating Excellence Scott Rogers, CBC Athletic Director Caitlyn Rhodes, Asst Coach for Volleyball Monica Cortez, Asst Coach for Volleyball Carolyn Smith, Asst Coach for Volleyball Omar Anderson, Head Coach Women's Soccer Kendra Selle, Asst Coach Women's Soccer Martin Ramirez, Head Coach Men's Soccer Sergio Licona, Asst Coach for Men's Soccer	CBC Athletic Director Scott Rogers introduced each of the 2022 fall athletic coaches to the Board. All of these coaches were hired during COVID and were able to recruit and train players for successful teams with a combined record of 100 wins and 28 losses. <u>Women's Soccer</u> – 2022 East Region champs, five players named as all-stars and participated in back-to-back final four with a record of 27 wins, 5 losses and 2 ties. <u>Men's Soccer</u> – Three-time East Region champs, five players named as all-stars, NWAC champions for the first time since 1999, back-to-back final four appearances and three players recognized nationally. Coach Ramirez noted how hard-working and disciplined his team was this year on the field and in the classroom – 12 will graduate and 7 will transfer to 4-year schools.

	ACT Winter Conference is scheduled for January 23 and 24 with Tuesday afternoon set	
	aside for visiting legislators at the Capitol. This will also be an opportunity to honor a CBC student, Ryla Christianson, selected as one of six students from across Washington to speak at the ACT Transforming Lives Awards Dinner.	
	CBC hired a new VP for Human Resources and Legal Affairs , Corey Osborn. He will begin work at CBC on February 1. We are very grateful to John Boesenberg for providing interim work for the past four months.	
	Upcoming training opportunities for trustees and Cabinet include Carver Model training in the summer of 2023 and a possible DEI work session for trustees in conjunction with	
	DEI trainers providing professional development for CBC staff and faculty. Trustees are welcome to attend any training provided on campus through special events or Teaching and Learning Professional Development Days.

	 The Foundation is wrapping up the year with a year-end appeal, holiday cards and treats being delivered to endowment donors and planned giving prospects. 	
	Planned gifts have been really important and in an effort to increase identified	
	gifts they are reviewing a new software platform.In an effort to evaluate professional services, the Foundation Board Finance	
	Committee is planning for a banking RFP.A scholarship application goes live in January so the Foundation is working with	
	the CBC outreach team to ensure thorough training on the application to provide support for incoming and potential students.	
	This past week the Foundation had the Columbia River Basin Chapter of the	
	Project Management Institute endow a scholarship for Project Management students which was very exciting. Next week, the Foundation will be announcing	
	a \$150,000 gift from HMIS designed to help prepare the next generation of	
	Hanford employees. The focus of this gift is to prepare CBC students with the necessary skills and knowledge to become a successful new workforce of	
	Hanford employees.The Board will likely start to see some changes to the planetarium soon. CPCCo	
	has agreed to a \$350,000 gift for naming rights. New signage will be going up.	

	 The gift is allowing CBC to celebrate the 10th anniversary of the planetarium with a new projector system set to be installed after the first of the year. We will have an event to celebrate in March. Gesa's Real Heroes Fund awarded the CBC Education Program \$20,000 for stipends to students in the program who are unable to work due to student teaching requirements. As the Foundation plans the calendar for next year, they wanted to give the Board dates for the following events — February 24 will be the Athletics Hall of Fame, June 3 will be CBC night with the Dust Devils and October 12 is Power of Connection.

Reports Cash Balance Report Variance Report	VP for Administrative Services, Eduardo Rodriguez, provided highlights from the Cash Balance and Variance Report.	
Mission Fulfillment Report (Spring Update)	 Dean for Organizational Learning, Jason Engle, provided the spring update of the Mission Fulfillment Report emphasizing degree completion. The majority of the data in the report can be found in Jedi II: Outcomes for disaggregation and inquiry. CBC's overall average rating this year, using the rating structure as outlined by Dr. Engle, is 3.11 and is on par with last year's results (3.14). In the summaries CBC highlights as a college (and are predictive of future completion and transfer): Our leading indicators continue to do well, or at least holding from last year. We can be more confident that last year was not just a "one-time" spike. Math, in particular, has extended double-digit gains in the third year of redesign. Course Success, particularly among transfer students, has increased again. Fall to fall retention has gone down significantly, extending losses from last year. Transitional Studies has struggled, which is magnified by enrollment related measures. Goal #1, Transfer or Completion by Year 3 is 32.2% overall, down from 34.3% last year, and not appreciably different than our last five years. Goal #2, 30 College Level Credit Attainment (Year 1) is 43.5% overall, up from 42.2% last year, and up appreciable over five years. Goal #3a, College Level English (Year 1) is 33.8% overall, slightly down from 34.4% last year, holding last year's increase. Goal #3b, College Level Math (Year 1) is 34.7% overall, up again from 31.3% last year.

	Predictive metrics show a 3-year completion for the 2021-22 cohort for 2023-24 at 39%, based on the percentage of students meeting each of the measured goal milestones.	
	When comparing SBCTC and CBC goals for 2029, CBC is holding statewide trends for 3- year Completion and College Level English (Year 1), and outperforming statewide trends for 30 College Level Credits (Year 1) and College Level Math (Year 1).	
	Retention levels in all categories (Fall to Winter, Fall to Spring, Fall to Fall), remain comparable to last year (2020-21) with the Fall to Fall retention at 46.1%.	
	Transitional Studies is still vulnerable to negative enrollment pressure and online courses last year due to 12-hour threshold (federally reportable) and the 45-hour threshold. The 45-hour threshold puts downward pressure on I-Best enrollment capabilities, measurable skills gains, and 3-year hours in both ABE and ELA. An area that is holding or saw gain is among the higher levels of ABE (ABE 4 or higher) where enrollment pressures have been lower and high school graduation is a more accessible reality (1 st to 2 nd year retention and HS Completion).

POLICY TYPE: EXECUTIVE LIMITATIONS EL-8 POLICY TITLE: COMMUNICATION AND SUPPORT TO THE BOARD

The President, with sufficient and relevant support and assistance from the College Leadership team (Vice-Presidents and Deans), shall not fail to proactively communicate, provide information and counsel to the Board in a timely manner.

Accordingly, the President shall not:

- 1. Fail to submit Monitoring and Performance data reports required by the Board in a timely, accurate and understandable format that directly addresses provisions of the Board policies being monitored.
- 2. Let the Board be unaware of relevant trends, anticipated adverse media coverage, material external and internal changes, and particularly changes in assumptions upon which any Board policy has previously been established.
- 3. Fail to advise the Board if, in the President's opinion, the Board is not in compliance with its own policies, particularly in the case of Board behavior which is detrimental to the work relationship between the Board and President.
- 4. Deprive the Board of as many staff and external points of view, issues and options as needed for fully-informed Board choices and decisions.
- 5. Present information in unnecessarily complex or lengthy format such that it fails to clearly differentiate between monitoring, Board decision preparation and other designated subject matter.
- 6. Withhold from the Board the support needed for its official functioning and communications.
- 7. Favor any Board Member or Members above the Board as a whole, except when fulfilling individual Board member requests for information.
- 8. Fail to report in a timely manner an actual or anticipated non-compliance with any Board policy.
- 9. Neglect to supply topics and/or issues that may need to be processed in the Board's "required approval agenda." Such topics and issues are those delegated to the President, yet required by law or contract to be Board-approved, along with monitoring assurance pertaining thereto.



POLICY TYPE: EXECUTIVE LIMITATIONS EL-9 POLICY TITLE: EMERGENCY EXECUTIVE SUCCESSION

To protect the Board from sudden loss of Chief Executive services, the President shall not have fewer than two other executives familiar with Board and Chief Executive issues and processes.



POLICY TYPE: EXECUTIVE LIMITATIONS EL-10 POLICY TITLE: TENURE

The Board of Trustees reserves the authority to grant tenure, extend the tenure and review process for probationary faculty, and dismiss tenured faculty at Columbia Basin College. Additionally the Board reserves the authority to renew or not renew contracts for probationary faculty, and to dismiss probationary faculty.

Accordingly, the President shall not:

- 1. Fail to submit recommendations to the Board to grant or deny tenure to faculty.
- 2. Fail to submit notice of sufficient cause for tenured faculty member dismissal through dismissal review proceedings for Board consideration and decision.
- 3. Fail to submit recommendations to the Board for the renewal or non-renewal of contracts for probationary faculty.
- 4. Fail to submit recommendations to the Board to issue the final order to dismiss probationary faculty.

POLICY TYPE: EXECUTIVE LIMITATIONS EL-5 POLICY TITLE: TREATMENT OF ASSET PROTECTION

Through operational compliance and leadership, the President shall not allow assets to be unprotected, inadequately maintained nor put at risk.

Accordingly, the President shall not:

- 1. Unnecessarily expose the organization, its Board or staff to claims of liability.
- 2. Fail to protect intellectual property, information and files from vulnerability, loss or significant damage.
- 3. Receive, process or disburse funds under controls that are insufficient to meet the Auditor's standards.
- 4. Jeopardize nor damage the organization's public image or credibility, particularly in ways that would hinder its accomplishment of mission.



POLICY TYPE: EXECUTIVE LIMITATIONS EL-6 POLICY TITLE: FINANCIAL PLANNING

Fiscal planning shall not deviate materially with the Board's *Ends* policies nor risk fiscal jeopardy. Accordingly, the President shall not cause or allow financial planning which:

- 1. Plans the expenditure in any fiscal year for more funds than are conservatively projected to be received in that period, plus accumulated reserve.
- 2. Contains insufficient and unnecessary information that limits or restricts credible projection of revenues and expenses, separation of capital and operational items, cash flow and disclosure of planning assumptions.
- 3. Limits or restricts sufficient funds for Board prerogatives during the year as set forth in the Board's annual activity and travel plans.



POLICY TYPE: EXECUTIVE LIMITATIONS EL-7

POLICY TITLE: FIDUCIARY RESPONSIBILITY / FINANCIAL CONDITION AND ACTIVITY

The Board of Trustees reserves the authority to set policies for and review the Financials and associated status for the College at a frequency determined by the Board. With respect to the Board's actual and continuous fiduciary responsibility, and the College's financial health, the President shall not fail to promote fiscal integrity and shall avoid material deviation from Board-approved priorities.

Accordingly, the President shall not:

- 1. Expend more funds than have been approved by the Board (via policy decisions) in the fiscal year, unless there has been Board approval to do otherwise.
- 2. Expend more funds than have been received in the fiscal year to date, plus the accumulated Reserve, unless the Board-approved debt guideline is met.
- 3. Incur debt in an amount greater than which can be repaid by certain and otherwise unencumbered revenues within the current year, nor can be repaid from account specifically established for such purpose.
- 4. Jeopardize fiscal integrity by expending College funds in a manner that will result in a zero nor negative fund balance at the close of the fiscal year.
- 5. Fail to settle payroll and debts in a timely manner.
- 6. Allow tax payments or other government-ordered payments or filings to be overdue and inaccurately filed.
- 7. Acquire, encumber nor dispose of real property without Board approval.
- 8. Fail to aggressively pursue receivables after a reasonable grace period.
- 9. Fail to provide to the Board, at their designated frequency, reports on the College's current financial condition that will continually enhance the Board's ability to meet its fiduciary responsibility.
- 10. Accept gifts or grants that are not in the best interest of the College, and not obligate the College to make future expenditures using funds other than those created by the gift or grant without Board approval.



- 11. Fail to maintain an Operating Reserve to a level approved by the Board, to provide for such items as, but not limited to:
 - a. Current Operations

Reserve of 2 months operating expenditures consisting of the general operating budget funds

- i. 001 State General (appropriation),
- ii. Running Start portion of 145 Grants and Contracts,
- iii. 148 Dedicated Local (fees),
- iv. 149 Local General (tuition)
- b. Emergencies

Reserve to provide for unforeseen natural or manmade disasters to support business continuity and recovery actions.

c. Unplanned Capital Repair & Replacement

Reserve to cover the largest system or component failure that might occur in or outside the biennial, legislatively funded, capital repair and minor improvement funding. Examples include roofs, HVAC, and electric, water, and sewer systems.

d. Real Estate Debt

Reserve to provide funding for real estate acquisition and debt service needs not provided for by State resources.

e. Planned Future Operations

Reserve for future new program offerings, which have been recognized by the campus as appropriate and within the educational mission of the College. The Reserve will recognize each specific project and provide an allocated amount for each.

f. Capital Facilities Projects Reserve to provide for capital facility projects not covered by or to supplement State resources.

The President shall not fail to annually recommend to the Board an amount to be set aside to maintain this fund, which is subject to approval by the Board.
