Linkage with Community Tri-City Regional Chamber of Commerce Lori Mattson, President & CEO	Dr. Woods introduced Lori. Lori talked about the AWB-WA Workforce Portal. The AWB workforce portal is a statewide interim pilot partnering with WSU and CBC. The Chamber hired Brooke Myrland as the Workforce & Education Program Manager to support the portal.	
By, Administration President	Dr. Rebekah Woods Fall quarter wrapped up: Classes have ended and finals are over. Grades were due today.  Legislative Event: On Monday morning the College and Walla Walla Community College hosted the annual event. All but two of our legislators attended. The highlight of the meeting were our amazing students that shared their stories and the impact our colleges have had on them.	
	WACTC met on Thursday and Friday of this month. Amazon is advocating for a bill this year with the legislature that would allow all CTCs to offer a BS in Computer Science, rather than just the BAS in Computer Science. They want the Seattle Promise to be able to	

help them diversify their employees, but want the BS degree credential rather than the BAS. This is not something our system will be advocating for, but are supportive of continuing to explore the concept.

Senator Christine Rolfes, Chair of the Senate Ways and Means, and Representative Timm Ormsby, Chair of the House Appropriations Committee, spoke with WACTC and shared their current projections on the state's budget and legislative priorities for next year. They reiterated positive news related to the state's budget and the impact on our system.

ACT shared that they will be sending a \$250 scholarship to each of the Transforming Lives nominees in the system for the first time. Our Foundation will also be providing a \$500 scholarship for all our students. All the nominees have been invited to the January board meeting.

Stimulus Bill: The bill includes more money for higher education than the CARES Act and more flexibility in spending. This money could help to support DACA students.

Theater Production: Dr. Woods attended a virtual play production of *Kid Simple: A Radio Play in the Flesh* performed live by our theater department, but aired on Zoom. Each student performed their role within their own personal plexi-glass booth.

MLK Spirit Award: The request is out seeking nominations for our next MLK Spirit Award winner. The award recognizes a student, faculty or staff member, or community member who strongly believes in equality and social justice; and whose contributions to society reflect the spirit, philosophy and teachings of Dr. Martin Luther King Jr. We are in the process of brainstorming some virtual options for the January ceremony. Nominations are due Thursday, December 17.

ACT Trustee Tuesdays: The first Trustee Tuesday presentation on the Carver Model will be held virtually on December 22.

Scholarships from the fall cycle were awarded this month. Total amount for 2020 was \$993,000 and went to 683 students. The first scholarship cycle of 2021 will open on January 1<sup>st</sup> and close on February 28<sup>th</sup>.

Year-end Communication-One last push for donor communication and fundraising. Year-end appeals went out last week to both donors and lapsed donors. Holiday cards are going out, and we will be delivering cookies this week to endowment donors.

RFP-A subcommittee is currently reviewing investment advisor proposals. Seven companies' submitted proposals. Four of the companies will be contacted for interviews in early January.

Donations-Women Helping Women Fund are providing \$10,000 for emergency funding specific to the Trio program. CH2M Hill has indicated that they will be sending an additional \$20,000 and Northwest Farm Credit Services will be making a significant donation to our Ag program that will be announced after the first of the year.

Wrap-up/Planning-As we wrap up 2020 we are proud that in addition to the scholarships, the foundation gave over \$85,000 in support to over 150 students through the emergency fund. \$1.2 million was provided in program support. We have spent the past few weeks evaluating our efforts and developing our plan for 2021.

### POLICY TYPE: EXECUTIVE LIMITATIONS EL-8

### POLICY TITLE: COMMUNICATION AND SUPPORT TO THE BOARD

The President, with sufficient and relevant support and assistance from the College Leadership team (Vice-Presidents and Deans), shall not fail to proactively communicate, provide information and counsel to the Board in a timely manner.

Accordingly, the President shall not:

- 1. Fail to submit Monitoring and Performance data reports required by the Board in a timely, accurate and understandable format that directly addresses provisions of the Board policies being monitored.
- 2. Let the Board be unaware of relevant trends, anticipated adverse media coverage, material external and internal changes, and particularly changes in assumptions upon which any Board policy has previously been established.
- 3. Fail to advise the Board if, in the President's opinion, the Board is not in compliance with its own policies, and particularly in the case of Board behavior which is detrimental to the work relationship between the Board and President.
- 4. Deprive the Board of as many staff and external points of view, issues and options as needed for fully-informed Board choices and decisions.
- 5. Present information in unnecessarily complex or lengthy format such that it fails to clearly differentiate between monitoring, Board decision preparation and other designated subject matter.
- 6. Withhold from the Board the support needed for its official functioning and communications.
- 7. Favor any Board Member of Members above the Board as a whole, except when fulfilling individual Board member requests for information.
- 8. Fail to report in a timely manner an actual or anticipated non-compliance with any Board policy.
- 9. Neglect to supply topics and/or issues that may need to be processed in its "required approval agenda." Such topics and issues are those delegated to the President, yet required by law or contract to be Board-approved, along with monitoring assurance pertaining thereto.

# POLICY TYPE: EXECUTIVE LIMITATIONS EL-9 POLICY TITLE: EMERGENCY EXECUTIVE SUCCESSION

To protect the Board from sudden loss of Chief Executive services, the President shall not have fewer than two other executives familiar with Board and Chief Executive issues and processes.



**POLICY TYPE: EXECUTIVE LIMITATIONS EL-10** 

**POLICY TITLE: TENURE** 

The Board of Trustees reserves the authority to grant tenure, extend the tenure and review process for probationary faculty, and dismiss tenured faculty at Columbia Basin College. Additionally the Board reserves the authority to renew or not renew contracts for probationary faculty, and to dismiss probationary faculty.

Accordingly, the President will not:

- 1. Fail to submit recommendations to the Board to grant or deny tenure to faculty.
- 2. Fail to submit notice of sufficient cause for tenured faculty member dismissal through dismissal review proceedings for Board consideration and decision.
- 3. Fail to submit recommendations to the Board for the renewal or non-renewal of contracts for probationary faculty.
- 4. Fail to submit recommendations to the Board to issue the final order to dismiss probationary faculty

# POLICY TYPE: EXECUTIVE LIMITATIONS EL-5 POLICY TITLE: TREATMENT OF ASSET PROTECTION

Through operational compliance and leadership, the President shall not allow assets to be unprotected, inadequately maintained nor put at risk.

Accordingly, the President shall not:

- 1. Unnecessarily expose the organization, its Board or staff to claims of liability.
- 2. Fail to protect intellectual property, information and files from vulnerability, loss or significant damage.
- 3. Receive, process or disburse funds under controls that are insufficient to meet the Auditor's standards.
- 4. Jeopardize nor damage the organization's public image or credibility, particularly in ways that would hinder its accomplishment of mission.



### POLICY TYPE: EXECUTIVE LIMITATIONS EL-6 POLICY TITLE: FINANCIAL PLANNING

Fiscal planning shall not deviate materially from the Board's *Ends* policies nor risk fiscal jeopardy. Accordingly, the President shall not cause or allow financial planning which:

- 1. Plans the expenditure in any fiscal year for more funds than are conservatively projected to be received in that period, plus accumulated reserve.
- 2. Contains insufficient and unnecessary information that limits or restricts credible projection of revenues and expenses, separation of capital and operational items, cash flow and disclosure of planning assumptions.
- 3. Limits or restricts sufficient funds for Board prerogatives during the year as set forth in the Board's annual activity and travel plans.



### POLICY TYPE: EXECUTIVE LIMITATIONS EL-7

### POLICY TITLE: FIDUCIARY RESPONSIBILITY / FINANCIAL CONDITION AND ACTIVITY

The Board of Trustees reserves the authority to set policies for and review the Financials and associated status for the College at a frequency determined by the Board. With respect to the Board's actual and continuous fiduciary responsibility, and the College's financial health, the President shall not fail to promote fiscal integrity and shall avoid material deviation from Board-approved priorities.

### Accordingly, the President shall not:

- 1. Expend more funds than have been approved by the Board (via policy decisions) in the fiscal year, unless there has been Board's approval to do otherwise.
- 2. Expend more funds than have been received in the fiscal year to date, plus the accumulated Reserve, unless the Board-approved debt guideline is met.
- 3. Incur debt in an amount greater than that which can be repaid by certain and otherwise unencumbered revenues within the current year, nor can be repaid from accountspecifically established for such purpose.
- 4. Jeopardize fiscal integrity by expending College funds in a manner that will result in a zero nor negative fund balance at the close of the fiscal year.
- 5. Fail to settle payroll and debts in a timely manner.
- 6. Allow tax payments or other government-ordered payments or filings to be overdue and inaccurately filed.
- 7. Acquire, encumber nor dispose of real property without Board approval.
- 8. Fail to aggressively pursue receivables after a reasonable grace period.
- 9. Fail to provide to the Board, at their designated frequency, reports on the College's current financial condition that will continually enhance the Board's ability to meet its fiduciary responsibility.
- 10. Accept gifts or grants that are not in the best interest of the College, and not obligate the College to make future expenditures using funds other than those created by the gift or grant without Board approval.



# **Board of Trustees**

- 11. Fail to maintain an Operating Reserve to a level approved by the Board, to provide for such items as, but not limited to:
  - a. Current Operations

Reserve of 2 months operating expenditures consisting of the general operating budget funds

- i. 001 State General (appropriation),
- ii. Running Start portion of 145 Grants and Contracts,
- iii. 148 Dedicated Local (fees),
- iv. 149 Local General (tuition)
- b. Emergencies

Reserve to provide for unforeseen natural or manmade disasters to support business continuity and recovery actions.

- c. Unplanned Capital Repair & Replacement
  - Reserve to cover the largest system or component failure that might occur in or outside the biennial, legislatively funded, capital repair and minor improvement funding. Examples include roofs, HVAC, and electric, water, and sewer systems.
- d. Real Estate Debt
  - Reserve to provide funding for real estate acquisition and debt service needs not provided for by State resources.
- e. Planned Future Operations
  - Reserve for future new program offerings, which have been recognized by the campus as appropriate and within the educational mission of the College. The Reserve will recognize each specific project and provide an allocated amount for each.
- f. Capital Facilities Projects
  - Reserve to provide for capital facility projects not covered by or to supplement State resources.

The President will not fail to annually recommend to the Board an amount to be set aside to maintain this fund, which is subject to approval by the Board.
