- You will be expected to discuss in detail your proposed strategy for academic success.
- IT WILL BE YOUR RESPONSIBILITY TO PROVIDE THE COMMITTEE MEMBERS WITH EVIDENCE TO SUGGEST YOU WILL BE SUCCESSFUL AT COLUMBIA BASIN COLLEGE FROM THIS POINT FORWARD.
- The Committee is not obligated to reinstate students, and it should be understood a petition for reinstatement does not guarantee you any rights to re-enroll at CBC.
